Upon discovering the damage to my car, I took it to a reputable auto body shop. I got an estimate of \$1830 to repair the car. I was told that I would need to leave the car with the shop for no less than I week. They recommended that I rent the car for 12 days, just to be sure, because of potential delays. (sometimes parts they order don't fit and have to be re-ordered. I went to Hertz Car Rental website and got an estimate for a 12-day rental. I've attached copies of both the repair estimate and the car rental quote.
